

Official Rules for the 2021 Chattanooga Southeast Tennessee Home Education Association (CSTHEA) Homeschool Expo \$50 Sweepstakes

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: Must be 18 years old as of date of entry. Must be a legal resident of the United States. The Campaign is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.
